Norms & Procedures

1. Engineering and Medical Entrance Exam

Eligibility: Open for all Marthomite students appearing for the Plus II/ Equivalent examinations with at least B+ Grade or above in 5 subjects /70% of marks in S.S.L.C./equivalent examination for the candidates awaiting the Plus II /equivalent results or 65% marks in the Plus II / equivalent examination. Applicant's annual family income must not exceed Rs.2 lakhs. Maximum amount of scholarship will be Rs.7500/-. Candidates once received the scholarship will not be eligible for the same course for a second term.

2. IRF/NET/SET

Eligibility: Open for all Marthomite students who scored 60% of marks in MA/M.Com or 65% marks in M.Sc. final year exam. For candidates awaiting the final year results, those having the above percentage for the first year will be considered. Applicant's annual family income must not exceed Rs.2 lakhs. Maximum amount of scholarship will be Rs.5000/-. Candidates once received the scholarship will not be eligible for the same course for a second term.

3. Civil Services

Eligibility: Open for all graduates with a minimum of 60% marks in Arts/Commerce subjects and 65% marks in Science/Engineering/Medicine etc. Applicant's annual family income must not exceed Rs.2 lakhs. Maximum amount of scholarship will be Rs.10000/-. Candidates once received the scholarship will not be eligible for the same course for a second term. Recipients of this scholarship for undergoing coaching for appearing for the preliminary examination are also eligible for the scholarship for undergoing coaching for appearing for the respective final examinations.

4. Management Studies

Eligibility: Open for all Marthomite students 60% marks in Arts/Commerce subjects and 65% marks in Science / Engineering examination. Maximum amount of scholarship will be Rs.7500/-. Applicant's annual family income must not exceed Rs.2 lakhs. Candidates once received the scholarship will not be eligible for the same course for a second term.

5. CA Foundation Course:

Eligibility: Open for all Marthomite students who successfully passed intermediate of CA conducted by the Institute of Chartered Accountants in India. Maximum amount of scholarship will be Rs.10000/-. Applicant's annual family income must not exceed Rs.2 lakhs. Candidates once received the scholarship will not be eligible for the same course for a second term.

Interested candidates must apply in the prescribed form with

- 1. Attested copies of certificates
- 2. Course and conduct certificate and recommendation letter from the institution where the candidate studied / is studying.
- 3. Recommendation from the respective vicars of the Mar Thoma Church with a declaration about the income of the candidate's family with details regarding the parent's occupation.

Scholarship will be released only after receiving a bonafide certificate from the coaching centre incorporating a statement about the total expenditure incurred for the course.
